Requirements in relation to technical/functional parameters:

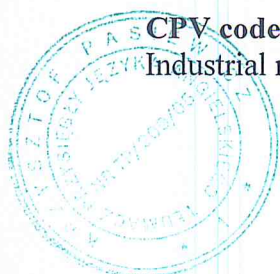
- operating width up to 2420 mm;
- possibility of temperature adjustment with the use of a heater and thermostat
- roll pressure through metal bar from grain feeding side
- controlled pneumatic pressure
- possibility of pressure bar replacement
- speed adjustment of pressure roll
- possibility of setting the number of cycles
- compliance with binding European standards and codes pertaining to operation safety;
- guarantee for correctness of machine operation with three-layer materials.

**Appraisal of offers**

Appraisal criterion and description of scoring method

The Employer shall select the most beneficial offer meeting the terms and conditions detailed in this RFQ.

When selecting the offer, the Employer shall follow the following criterion:

1. Offer net price; weight of: 80%; scoring method: assessment on the basis of offer form

$C = \text{lowest net price} / \text{net price of examined offer} * 100 \text{ points}$

2. Guarantee term – in general (in months) for delivered building works and installed devices including required device service; weight of: 20%; scoring method: assessment on the basis of offer form;

$G = \text{guarantee term of the examined offer (in months)} / \text{max. guarantee term (in months)} * 100 \text{ points}$

Max. score available: 100 points

Min. required guarantee term: 24 months from the date of use permit.

The scores counted for a given criterion shall be multiplied by the % significance of a given criterion and summed up together.  $P = C * 80\% + G * 20\%$

The appraisal obtained shall be rounded to two decimal points. The Employer shall award the order to a contractor whose offer meets all the terms and conditions and obtains the highest score is awarded.
